Sadly we recently lost a few of our beloved neighbors. Though they have passed on, they will never be forgotten.



Dust-Oiling of Unpaved Roads 5 June 2018

Objective:

To provide a long-lasting, costeffective, environmentally friendly dust abatement solution to address the public health concerns of our membership related to the dust produced from our unpaved roads.

South Theo Road

At the 26 May 2018 Spring Membership Meeting, Members voted to allot money for a dustoil solution to improve road & health conditions. The SAE Board & Project Team worked with Stevens County, the Department of Ecology, & EPA guidance to identify a solution. Tak Petroleum applied emulsified asphalt to our unpaved roads on 5 June 2018.
